ABSENTEE BID RULES

1. Bidders must purchase a ticket to the KCAC's 2011 Annual Benefit Auction and obtain a bidder number. Tickets for the auction cost \$25. Tickets and Bidder Numbers may be purchased by phone.
2. All bidders must submit a payment for the total bid amount with this form. Accepted forms of payment for purchase price are Visa, MasterCard, American Express, Discover, Personal or Business Check, Cashier's Check or Money Order. KCAC will return deposit checks to the unsuccessful bidders and will not process credit card deposit payments submitted by unsuccessful bidders.
3. All bids must be submitted on the Absentee Bid Form attached to these rules, which must be fully completed and signed by the bidder. The Absentee Bid Form and payment must be placed in a Absentee envelope with the bidder's name, bidder number and "Absentee Bid for KCAC Art Auction" printed on the outside of the envelope.
4. Bidders may submit bids either in person at KCAC's office or by mail to 201 Wyandotte, Kansas City, Missouri, 64105. In person bids must be placed with a KCAC staff member at KCAC's office before 9pm on February 15, 2012. Mailed bids must be received by KCAC on or before February 14, 2012.
5. KCAC will open the Absentee bids before the Live Auction. If two or more bidders submit the highest bid, the bid that was received first will take precedence. The bid will be made during the Live Auction. KCAC will announce the successful bidder number at the Live Auction. If the bidder is not present KCAC will contact the successful bidder by telephone on February 19, 2012.
6. The successful bidder shall be responsible for picking up the Artwork from KCAC's office at a time and date determined by the parties. If payment of the purchase price is paid by personal or business check, the Artwork may not be picked up until the check has cleared and the funds are available to KCAC.
7. By signing and submitting a bid, the bidder acknowledges and agrees that (i) the estimated value of the Artwork/s provided by KCAC does not constitute a representation or warranty by KCAC of the market value of the Artwork, (ii) the bidder has had an opportunity to fully inspect the Artwork/s, (iii) the bidder's bid amount was based solely on the bidder's own independent judgment of the value of the Artwork/s to bidder and (iv) the Artwork/s are being sold "AS IS" without any warranty, express or implied.
8. KCAC reserves the right to accept or reject any bids submitted at its sole discretion.

Terms of sale:

1. All sales are final. There are no refunds.
2. Absentee bidders must be at least 21 years of age.
3. No buyers' or sellers' fees will be added to the hammer price.
4. Buyers are responsible for pickup within 7 days or having purchases shipped.
